## 1. Introduction

### 1.1 FTSE 30-Year TIPS (Treasury Rate-Hedged) Index

- 1.1.1 The FTSE 30-Year TIPS (Treasury Rate-Hedged) Index is designed to measure the performance of the Break Even Rate of Inflation (BEI) which is the difference in yield between a US Treasury bond and a US Treasury Inflation Protected Securities (TIPS). The index includes three positions – the first is a long position of the most recently issued 30-Year TIPS, the second is a short position of a US Treasury bond<sup>1</sup>, and the third is a cash equivalent security that represents the repo rate earned on the short position.
- 1.1.2 The index's short position is the Cheapest-to-Deliver (CTD) Treasury bond for the Nearest-to-Expiry Ultra US Treasury Bond Futures Contract. The par amount of the index's short position is determined by creating a modified duration dollar neutral position between the CTD Treasury Bond (short position) relative to the 30-Year TIPS (long position), see the Hedging Methodology section.
- 1.1.3 The FTSE 30-Year TIPS (Treasury Rate-Hedged) Index does not take account of ESG factors in its design.

### 1.2 FTSE Russell

## 2. Management responsibilities

### 2.1 FTSE International Limited (FTSE)

2.1.1 FTSE is the benchmark administrator of the index series.<sup>2</sup>

2.1.2 FTSE is responsible for the daily calculation, production and operation of the index series and will:

- maintain records of the index weightings of all constituents;
- make changes to the constituents and their weightings in accordance with the Ground Rules;
- carry out the periodic index reviews of the index series and apply the changes resulting from the reviews as required by the Ground Rules;
- disseminate the indices.

### 2.2 Amendments to these Ground Rules

2.2.1 These Ground Rules shall be subject to regular review (at least once a year) by FTSE Russell to ensure that they best reflect the aim of the index series. Any proposals for significant amendments to these Ground Rules will be subject to consultation with FTSE Russell advisory committees and other stakeholders if appropriate. The feedback from these consultations will be considered by the FTSE Russell Index Governance Board before approval is granted.

2.2.2 As provided for in the Statement of Principles for FTSE Russell Fixed Income Indices, where FTSE Russell determines that the Ground Rules are silent or do not specifically and unambiguously apply to the subject matter of any decision, any decision shall be based as far as practical on the Statement of Principles. After making any such determination, FTSE Russell shall advise the market of its decision at the earliest opportunity. Any such treatment will not be considered as an exception or change to the Ground Rules, or to set a precedent for future action, but FTSE Russell will consider whether the Ground Rules should subsequently be updated to provide greater clarity.

### 3. FTSE Russell Index policies

#### 3.1 Statement of Principles for FTSE Fixed Income Indices (the Statement of Principles)

Indices need to keep abreast of changing markets and the Ground Rules cannot anticipate every eventuality. Where the Ground Rules do not fully cover a specific event or development, FTSE Russell will determine the appropriate treatment by reference to the Statement of Principles for FTSE Fixed Income Indices which summarises the ethos underlying FTSE Russell's approach to index construction. The Statement of Principles is reviewed annually, and any changes proposed by FTSE Russell are presented to the FTSE Russell Index Advisory Board for discussion before approval by the FTSE Russell Product Governance Board.

## 4. Composition and design criteria

### Design criteria and calculation assumptions for the FTSE 30-Year TIPS (Treasury Rate-Hedged) Index

<b>Coupon</b>	Fixed rate
<b>Currency</b>	USD
<b>Minimum maturity</b>	At least one year
<b>Minimum issue size</b>	TIPS (Long Position): USD 5 billion US Treasury bond (Short Position): USD 5 billion public amount outstanding (excludes Federal Reserve holdings)
<b>Minimum credit quality</b>	BBB- by S&P or Baa3 by Moody's
<b>Composition</b>	30-Year TIPS, Cheapest-to-Deliver (CTD) US Treasury bond, cash equivalent security
<b>Rebalancing</b>	Once a month on the last business day of the month (pricing as of the last business day of the month and settlement as of the last calendar day of the month)
<b>Reinvestment of cash flows</b>	Intra-month cash flows from interest and principal payments are not reinvested as part of monthly index total return calculations. <sup>6</sup>
<b>Pricing</b>	IDC bid-side at 3:00 p.m. (New York)
<b>Calculation frequency</b>	Daily
<b>Settlement date</b>	Monthly: Settlement is on the last calendar day of the month. Daily: Same day settlement except if the last business day of the month is not the last calendar day of the month; then, settlement is on the last calendar day of the month.
<b>Fixing date</b>	Each month, the upcoming month's index constituents are "fixed" on the profile fixing date. Each year's scheduled fixing dates are published on the website.
<b>Base date</b>	February 28, 2010

## 4.1 Hedging methodology

- 4.1.1 On Fixing Day, the modified duration dollars<sup>7</sup> of the 30-Year TIPS is calculated. Modified duration dollars are defined as:

$$\text{Modified Duration Dollars} = DV01 * \text{Par Amount}$$

where DV01 is the magnitude of the price change for the security when the yield curve moves one basis point.

- 4.1.2 The CTD of the Nearest-to-Expiry Ultra US Treasury Bond Futures Contract is determined using the Yield Book's Treasury Future Option Model. The par amount for this short position is the amount such that the modified duration dollars of the short position is equal to the modified duration dollars of the long position, as defined below:

$$DV01_{\text{TIPS Position}} * \text{Par Amount}_{\text{TIPS Position}} = DV01_{\text{Treasury Position}} * \text{Par Amount}_{\text{Treasury Position}}$$

- 4.1.3 After the par amount of the short position is determined, a cash equivalent security is added to represent the repo rate earned on the short position. The amount of the cash position is equal to the market value of the short position as of Fixing Date.

## 4.2 Return calculation methodology

- 4.2.1 Returns are calculated based on the dollar return of each position in the index. Any coupon paid during the month from the long position is reinvested at the daily average of the one-month Euro deposit rate, calculated from the actual scheduled payment date of the cash flow through the end of the reporting period. The cash equivalent security is reinvested at the average of the bid and ask prices on the 1-Month Government Repo Rate as of the Fixing Date. The overall index return is calculated based on the summation of the dollar returns of each position divided by the beginning market value of the long position:

$$\frac{\text{Dollar Return}_{\text{Long Position}} + \text{Dollar Return}_{\text{Short Position}} + \text{Dollar Return}_{\text{Cash Position}}}{\text{Beginning Market Value}_{\text{Long Position}}}$$

## 4.3 Holiday calendar

- 4.3.1 The index is calculated Monday through Friday except Christmas Day (observed) and New Year's Day (observed). Each local market will observe its own holiday calendar; if a local market is on holiday, the closing prices used for that day will be the closing prices from the previous day.

## 4.4 Index quality

- 4.4.1 An index quality is assigned to each index bond as of profile fixing. The quality is first mapped to the Standard & Poor's Financial Services LLC ("S&P") rating. If a bond is not rated by S&P but it is rated by Moody's Investors Service, Inc ("Moody's"), the S&P equivalent of the Moody's rating is assigned to the index quality. If a bond is rated by neither S&P nor Moody's, the bond is not assigned an index quality. If a bond is rated as investment-grade by one rating agency and high-yield by the other, the S&P equivalent of the investment-grade rating is assigned to the index quality. These ratings remain unchanged for the entire performance month.

## 4.5 Return computation

- 4.5.1 Total returns are computed on the assumption that each security is purchased at the beginning of the period and sold at the end of the period. An issue's total rate of return is the percentage change in its total value over the measurement period (see Figure 1). The components of total return are price change, principal payments, coupon payments and accrued interest. The total returns use each individual security's beginning-of-period market value.

Figure 1. Total rate of return calculation methodology

Beginning-of-period value	-	(Beginning price + Beginning accrued) x Beginning par amount outstanding
End-of-period value	-	[(Ending price + Ending accrued) x (Beginning par amount outstanding – Principal payments)] + Coupon payments + Principal payments
Total rate of return (%)	-	[(End-of-period value/Beginning-of-period value) – 1] x 100

A note on precision: Returns are computed to at least six decimal places but reported to a maximum of four. In addition, owing to rounding errors inherent in computer floating-point arithmetic, the last digit in any reported value may sometimes be off by one from its true value.
