### Introduction

#### 1. Introduction

#### 1.1 FTSE US Treasury Short Duration Index

- 1.1.1 The FTSE US Treasury Short Duration Index measures the performance of short-duration US Treasury securities.
- 1.1.2 The FTSE US Treasury Short Duration Index does not take account of ESG factors in its design.

#### 1.2 FTSE Russell

# Management responsibilities

### Management responsibilities

#### 2.1 FTSE Fixed income LLC (FTSE)

- 2.1.1 FTSE is the benchmark administrator of the index<sup>1</sup>.
- 2.1.2 FTSE is responsible for the daily calculation, production and operation of the index series, and will:
  - maintain records of the index weightings of all constituents;
  - make changes to the constituents and their weightings in accordance with the ground rules;
  - carry out the periodic index reviews of the index series and apply the changes resulting from the reviews as required by the ground rules; and
  - disseminate the indices.

#### 2.2 Amendments to these ground rules

- 2.2.1 These ground rules shall be subject to regular review (at least once a year) by FTSE Russell to ensure that they best reflect the aim of the index series. Any proposals for significant amendments to these ground rules will be subject to consultation with FTSE Russell advisory committees and other stakeholders if appropriate. The feedback from these consultations will be considered by the FTSE Russell Index Governance Board before approval is granted.
- As provided for in the Statement of Principles for FTSE Russell Fixed Income Indices, where FTSE Russell determines that the ground rules are silent or do not specifically and unambiguously apply to the subject matter of any decision, any decision shall be based as far as practical on the Statement of Principles. After making any such determination, FTSE Russell shall advise the market of its decision at the earliest opportunity. Any such treatment will not be considered as an exception or change to the ground rules, or to set a precedent for future action, but FTSE Russell will consider whether the ground rules should subsequently be updated to provide greater clarity.

These policies are reviewed annually and any changes are approved by the FTSE Russell Product Governance Board.

#### 3.1 Statement of Principles for FTSE Fixed Income Indices (the Statement of Principles)

Indices need to keep abreast of changing markets and the ground rules cannot anticipate every eventuality. Where the ground rules do not fully cover a specific event or development, FTSE Russell will determine the appropriate treatment by reference to the Statement of Principles for FTSE Fixed Income Indices, which summarises the ethos underlying FTSE Russell's approach to index construction. The Statement of Principles is reviewed annually and any changes proposed by FTSE Russell are presented to the FTSE Russell Index Advisory Board for discussion before approval by the FTSE Russell Product Governance Board.

#### 3.5 FTSE Russell Governance Framework

3.5.1 To oversee its indices, FTSE Russell employs a governance framework that encompasses product, service and technology governance. The framework incorporates the London Stock Exchange Group's three lines of defence risk management framework and is designed to meet the requirements of the IOSCO Principles for Financial Benchmarks<sup>2</sup>, the European benchmark regulation<sup>3</sup> and the UK benchmark regulation<sup>4</sup>. #### Design criteria and calculation assumptions for the FTSE US Treasury Short Duration Index

Coupon	Fixed rate and floating rate
Minimum maturity <sup>5</sup>	One month
Maximum maturity	Fixed rate: one year Floating rate: three years
Minimum issue size	USD 5 billion public amount outstanding (excludes Federal Reserve holdings)
Composition	Securities included: fixed rate and floating rate US Treasury securities with an original maturity of 10 years or less at issue and US Treasury bills with an original maturity of one year at issue.
	Securities excluded: TIPS, Strips, callable treasuries, bonds with an original maturity greater than 10 years at issue and treasury bills with an original maturity of less than one year at issue.
Weighting	Market capitalisation
Rebalancing	Once a month at the end of the month.
Reinvestment of cash flows	Intra-month cash flows from interest and principal payments are not reinvested as part of monthly index total return calculations <sup>6</sup> .
Pricing	Refinitiv bid-side evaluated pricing at 15:00 (New York).
Calculation frequency	Daily
Settlement date	Monthly: settlement is on the last calendar day of the month.
	Daily: same-day settlement except if the last business day of the month is not the last calendar day of the month; then, settlement is on the last calendar day of the month.
Fixing date	Each month, the upcoming month's index constituents are fixed on the profile fixing date. The profile fixing dates for each year are available on the website at <a href="https://www.yieldbook.com/m/indices/">www.yieldbook.com/m/indices/</a> .
Base date	28 February 2014

#### 4.1 Holiday calendar

4.1.1 The index is calculated Monday through Friday except Christmas Day (observed) and New Year's Day (observed). Each local market will observe its own holiday calendar: if a local market is on holiday, the closing prices used for that day will be the closing prices from the previous day.

#### 4.2 Index quality

An index quality is assigned to each index bond as of profile fixing. The quality is first mapped to the Standard & Poor's Financial Services LLC (S&P) rating. If a bond is not rated by S&P but it is rated by Moody's Investors Service, Inc (Moody's), the S&P equivalent of the Moody's rating is assigned to the index quality. If a bond is rated by neither S&P nor Moody's, the bond is not assigned an index quality. If a bond is rated as investment grade by one rating agency and high yield by the other, the S&P equivalent of the investment-grade rating is assigned to the index quality. These ratings remain unchanged for the entire performance month.

#### 4.3 Return computation

4.3.1 Total returns are computed on the assumption that each security is purchased at the beginning of the period and sold at the end of the period. An issue's total rate of return is the percentage change in its total value over the measurement period. The components of total return are price change, principal payments, coupon payments and accrued interest. The total returns use each individual security's beginning-of-period market value (see figure one).

#### Figure one: total rate of return calculation methodology

Beginning-of-period value	-	(Beginning price + Beginning accrued) x Beginning par amount outstanding
End-of-period value	-	[(Ending price + Ending accrued) x (Beginning par amount outstanding – Principal payments)] + Coupon payments + Principal payments
Total rate of return (%)	-	[(End-of-period value/Beginning-of-period value) – 1] x 100

A note on precision: returns are computed to at least six decimal places but reported to a maximum of four. In addition, owing to rounding inaccuracies inherent in computer floating-point arithmetic, the last digit in any reported value may sometimes be off by one from its true value.

#### **FTSE US Treasury Short Duration Index event summary**

Year	Monthly highlights
2022	<b>November:</b> intra-month cash flows from interest and principal payments are not reinvested as part of monthly index total return calculations.
2019	March: the maturity eligibility criteria are updated to include US Treasury bonds with original maturity of 10 years or less at issue and exclude US Treasury bills with original maturity of less than one year at issue.
2018	November: the pricing source is changed from Citi traders to Refinitiv.
