FTSE 0+ Years Fixed Income Index Series

A comprehensive range of hold-to-maturity fixed income indices

FTSE Russell offers a comprehensive, flexible range of 0+ years fixed income indices across a broad range of markets and across all maturity segments. The series allows investors to track existing flagship FTSE fixed income indices without the traditional minimum one year to maturity rule, providing an alternative, hold-to-maturity strategy. The indices are launched with comprehensive daily historical time series supported by Refinitiv pricing and reference data. With granular sub-indices, including 0-1, 0-3 and 0-5 year term buckets as standard, investors can easily track exposures at the short end of the curve, without the need for customisation.

Short-term

There is already strong structural demand for money market products, and this may be heightened in periods of uncertainty and market stress, which can cause a 'flight-to-safety' rotation from longer-duration to shorter-duration exposures, or in periods of expected inflation.

Cash Reinvestment

Short-term government bond markets are liquid and provide a reinvestment vehicle for cash holdings.

Short Duration

The short segments of bond markets have lower duration and relatively lower interest rate sensitivity than longer term buckets.

Modular construction provides flexibility for a range of customisations across other attributes, such as country, quality, sector and asset type.

Buy & Hold

Within fixed income, indices typically specify that bonds must have a minimum of one year to maturity remaining to be eligible for inclusion, meaning that sub 1 year bonds exit the index at rebalance. The 0+ year methodology removes this rule, and tracks bonds through to a minimum of one month to maturity instead.

Adding the 0-1 year term bucket to long-term indices eliminates force-selling, allowing investors to track their holdings below the 1 year mark.

Broad 0+ year coverage of a variety of global fixed income markets

The 0+ year version of each flagship 1+ year benchmark tracks the universe of securities that meet the eligibility criteria for the existing index through to maturity, allowing for a seamless transition for index users looking to better replicate their strategies.

FTSE Russell recognises the growing demand for indices that allow for passive hold-to-maturity strategies, reducing turnover and transaction costs.

A collection of standalone 0+ year indices designed to measure the performance of securities that meet the eligibility criteria for existing 1+ year indices, through to one month to maturity remaining.
