## Section 1 Introduction

## 1. Introduction

- 1.1 This document sets out the Ground Rules for the construction and management of the FTSE Alinma Emerging Islamic Customised Index calculated by FTSE International Limited (FTSE).
- 1.2 The FTSE Alinma Emerging Islamic Customised Index (GPALI001) has been designed to create an index with the objective to identify the Top 200 largest securities within the FTSE IdealRatings Emerging Islamic Index with a market capitalisation value greater than or equal to USD 1 billion ranked by investable market capitalisation.
- 1.3 These Ground Rules should be read in conjunction with the FTSE IdealRatings Islamic Index Series Ground Rules and the FTSE Russell Corporate Actions and Events Guide which are available at <u>www.lseg.com/en/ftse-russell/</u>.

#### 1.4 Price and Total Return Index will be calculated on an end of day basis.

The Total Return Index includes income based on ex dividend adjustments. All dividends are applied as declared in the FTSE Total Return Index.

- 1.5 Index values are calculated in USD and may also be published in other currencies.
- 1.6 The FTSE Alinma Emerging Islamic Customised Index does not take account of ESG factors in its index design.

## 1.7 FTSE Russell

FTSE Russell is a trading name of FTSE International Limited, Frank Russell Company, FTSE Global Debt Capital Markets Limited (and its subsidiaries FTSE Global Debt Capital Markets Inc. and FTSE Fixed Income Europe Limited), FTSE Fixed Income LLC, The Yield Book Inc and Beyond Ratings.

## Section 2 Management responsibilities

## 2. Management responsibilities

### 2.1 FTSE International Limited ("FTSE")

- 2.1.1 FTSE is the benchmark administrator of the index.<sup>1</sup>
- 2.1.2 FTSE is responsible for the daily calculation, production and operation of the FTSE Alinma Emerging Islamic Customised Index and will:
  - maintain records of the index weightings of all constituents and reserve companies;
  - make changes to the constituents and their weightings in accordance with the Ground Rules;
  - carry out the periodic index reviews of the index and apply the changes resulting from the reviews as required by the Ground Rules;
  - publish changes to the constituent weightings resulting from their ongoing maintenance and the periodic reviews;
  - disseminate the index.

## 2.2 Amendments to these Ground Rules

- 2.2.1 These Ground Rules shall be subject to regular review (at least once a year) by FTSE Russell to ensure that they continue to meet the current and future requirements of investors and other index users. Any proposals for significant amendments to these Ground Rules will be subject to consultation with FTSE Russell advisory committees and other stakeholders if appropriate. The feedback from these consultations will be considered by the FTSE Russell Index Governance Board before approval is granted.
- 2.2.2 As provided for in the Statement of Principles for FTSE Russell Equity Indexes, where FTSE Russell determines that the Ground Rules are silent or do not specifically and unambiguously apply to the subject matter of any decision, any decision shall be based as far as practical on the Statement of Principles. After making any such determination, FTSE Russell shall advise the market of its decision at the earliest opportunity. Any such treatment will not be considered as an exception or change to the Ground Rules, or to set a precedent for future action, but FTSE Russell will consider whether the Ground Rules should subsequently be updated to provide greater clarity.

The term administrator is used in this document in the same sense as it is defined in <u>Regulation (EU) 2016/1011 of the European Parliament and of the Council of 8 June 2016 on</u> indices used as benchmarks in financial instruments and financial contracts or to measure the performance of investment funds (the European Benchmark Regulation) and <u>The</u> <u>Benchmarks (Amendment and Transitional Provision) (EU Exit) Regulations 2019</u> (the UK Benchmark Regulation).

### 3.2 Statement of Principles for FTSE Russell Equity Indexes (the Statement of Principles)

Indexes need to keep abreast of changing markets and the Ground Rules cannot anticipate every eventuality. Where the Ground Rules do not fully cover a specific event or development, FTSE Russell will determine the appropriate treatment by reference to the Statement of Principles which summarises the ethos underlying FTSE Russell's approach to index construction. The Statement of Principles is reviewed annually and any changes proposed by FTSE Russell are presented to the FTSE Russell Policy Advisory Board for discussion before approval by the FTSE Russell Index Governance Board.

## 4. Eligible securities

- 4.1 The index universe of the FTSE Alinma Emerging Islamic Customised Index is the FTSE IdealRatings Emerging Islamic Index.

## 5. Periodic review of constituent companies

## 5.1 Review dates

5.1.1 The semi-annual review will be conducted in line with the FTSE IdealRatings Emerging Islamic Index and will be implemented after the close of trading on the third Friday of March and September.

## 5.2 Review procedure

- 5.2.1 The FTSE IdealRatings Emerging Islamic Index is ranked by investable market capitalisation.
- 5.2.2 Closing price data on the Wednesday before the first Friday of March and September are used to determine the ranking.
- 5.2.3 Top 200 largest securities are selected, which have an investable market capitalisation value greater than or equal to USD 1 billion.

## 6. Changes to constituent companies

## 6.1 Intra-review additions

6.1.1 Additions to the FTSE Alinma Emerging Islamic Customised Index will be considered for inclusion at the next semi-annual review.

## 6.2 Intra-review deletions

6.2.1 A constituent will be removed from the FTSE Alinma Emerging Islamic Customised Index if it is also removed from the underlying Index. The deletion will be concurrent with its deletion from the underlying Index and its weight will be distributed pro-rata amongst the remaining constituents in the FTSE Alinma Emerging Islamic Customised Index.

## Section 7 Corporate actions and events

## 7. Corporate actions and events

7.1 Full details of changes to constituent companies due to corporate actions and events can be accessed in the Corporate Actions and Events Guide for Market Capitalisation Weighted Indexes using the following link:

A Corporate 'Action' is an action on shareholders with a prescribed ex date. The share price will be subject to an adjustment on the ex date. These include the following:

- Capital Repayments
- Rights Issues/Entitlement Offers
- Stock Conversion
- Splits (sub-division)/Reverse splits (consolidation)
- Scrip issues (Capitalisation or Bonus Issue)

A Corporate 'Event' is a reaction to company news (event) that may impact the index depending on the index rules. For example, a company announces a strategic shareholder is offering to sell their shares (secondary share offer) – this could result in a free float weighting change in the index. Where an index adjustment is required FTSE Russell will provide notice advising of the timing of the change.

## 7.2 Takeovers, mergers and demergers

## 8. Index calculation

## 8.1 Prices

8.1.1 The FTSE Alinma Emerging Islamic Customised Index uses actual closing mid-market or last trade prices, where available, for securities with local market quotations. Further details can be accessed using the following link:

## 8.2 Calculation frequency

8.2.1 The FTSE Alinma Emerging Islamic Customised Index will be calculated on an end of day basis.

## 8.3 Index calculation

8.3.1 The FTSE Alinma Emerging Islamic Customised Index is calculated using the following formula:

$$\sum_{i=1}^{N} \frac{(p_i \times e_i \times s_i \times f_i)}{d}$$

Where,

- *i*=1,2,...,N
- N is the number of securities in the index.
- $-p_i$  is the latest trade price of the component security (or the price at the close of the index on the previous day).
- e<sub>i</sub> is the exchange rate required to convert the security's currency into the index's base currency.
- s<sub>i</sub> is the number of shares in issue used by FTSE Russell for the security, as defined in these Ground Rules.
- *f<sub>i</sub>* is the Investability Weighting Factor to be applied to a security to allow amendments to its weighting, expressed as a number between 0 and 1, where 1 represents a 100% free float. This factor is published by FTSE Russell for each security in the underlying index.
- d is the divisor, a figure that represents the total issued share capital of the index at the base date. The divisor can be adjusted to allow changes in the issued share capital of individual securities to be made without distorting the index.
